Purpose & Amount

"...The income from the investments...shall be used to provide scholarships to needy young men and women in Kentucky Baptist Schools, each scholarship to be \$750* per school year."

*Amount increased to \$2,000.00 by Kentucky Baptist Foundation Board of Directors on September 22, 2022 in accordance with the order of Jefferson Circuit Court dated January 16, 2002.

Selection Procedure

"...To be selected by the Directors of the Kentucky Baptist Foundation, with the request that children cared for in the Kentucky Baptist Children's Homes, who are eligible, be preferred recipients."

Clear Creek Baptist Bible College, Southern Baptist Theological Seminary, and Boyce College

Annual Allocation Formula

To maximize the number of students awarded scholarships when qualified applicants exceed the scholarships available, ministerial students will be awarded Ruby King Scholarships first
