Scholarship Guidelines

Background

This fund was established by a \$10,000 bequest of the late Raymond C. Schnur Sr. received by the Foundation on November 30, 1986.

Purpose

"...For scholarships of children of foreign missionaries who are attending Kentucky Baptist colleges."

Definition

"Foreign missionaries" interpreted by the Scholarship Committee to include foreign missionaries who are active at the time of application or career missionaries who retired from active foreign missions service. (Schol. Com., KBF 5/28/09)

Amount

The scholarship award amount shall be determined each year by the Scholarship Selection Committee and may be spread among eligible recipients. The scholarship award amount may vary from year to year, depending on the Available Distribution Amount and the number of eligible recipients. If no student(s) qualify in any given year, the income shall be reinvested into the principal.

Selection

The recipients shall be selected by the Scholarship Committee of the Board of Directors of the Kentucky Baptist Foundation.
